**Action required** For schools in Wales to be able to comply with statutory duties in supplying the required data returns, the Welsh Government recommends that software suppliers of school management information systems that have customers in Wales take full consideration of this specification document when developing their systems.

## 2. Introduction

This specification describes the content of the Wales PLASC for **January 2026**. It applies to all maintained schools required to provide the Welsh Government with pupil level and school level data.

PLASC is mandatory for all sectors (nursery, primary, middle, secondary and special schools) and all pupils on roll on the census date must be included in the return.

The provision of electronic returns for pupil referral units (PRUs) is not specified within this collection as provision of data for PRUs is via the Educated Otherwise Than At School (EOTAS) local authority level collection.

The census date for the 2026 collection is **20 January 2026**.

This specification follows the principles set out below: suppliers are asked to note the document in its entirety and provide early feedback on issues and queries during the specification review period.

### 2.1 Key principles

Electronic pupil level data collections from schools, including the PLASC, are carried out in line with the principles set out in the [Welsh Government's Information Management Strategy](https://gov.wales/information-management-for-schools) at <https://gov.wales/information-management-for-schools>

PLASC collects pupil level and school level data items.

All data items are as defined in the relevant Common Basic Data Set (CBDS) documentation for Wales.

Data are grouped into modules.

Pupil level items will be collected as whole modules.

New items for collection have been previously notified to software suppliers by separate notification and agreement with the Software Development Forum (SDF).

### 2.2 Extensible markup language (XML) tools

In order to reduce burdens on software suppliers and enhance consistency of validation application across suppliers and the [Welsh Government's](#) systems, the [Welsh Government](#) will provide a number of XML tools for optional use by suppliers. Please see the extensible stylesheet language transformations (XSLT) design specification for requirements for, and further details on, implementing the XSLT in MIS software.

## XML schema definition (XSD)

XSD files will be provided for each return type, which will define the content of the XML return.

## Extensible stylesheet language transformations (XSLT) validation

A set of XSLT applications will be provided to validate the census return files; these will replicate the validation rules specified for this collection. A later section of this specification lists the Validation CBDS document to refer to. The XSLT will produce hypertext markup language (HTML) and XML error reports.

## XSLT summary reporting

A further set of XSLT applications will be provided to process the XML data return and produce a school summary report. This will replicate the reports as set out in a later section of this specification.

## Production of XSD and XSLT

XML tools for this collection are scheduled to be released in the summer of 2025

## 2.3 Purpose of the collection

The PLASC provides a great level of detail, at individual pupil level, on the school population in Wales providing an invaluable research base to better inform educational policy and practice in Wales.

Amongst the most important uses for the data provided by the PLASC are:

- the fair and accurate distribution of funding to schools through the Welsh Local Government Revenue Settlement;
- the allocation of each school to a family of broadly equivalent schools based on contextual factors derived from PLASC;
- the update of the All Wales Core Data Sets (AWCDS) which links pupils' records to assessment and provides schools, local authorities and central government with access to previously complex statistical analyses; and
- a greater accuracy of pupil level data to help schools to adhere to the principles of the [Data Protection Act \(DPA\) 2018](#).

## 2.4 Changes to previous data items

### Special educational needs data items removal

As referred to in previous years' software specification as future changes, with the introduction of Individual Development Plans (IDPs), stemming from the [Additional Learning Needs Code for Wales 2021](#), created under section 4 of the [Additional Learning Needs and Education Tribunal \(Wales\) Act 2018](#), following a multi-year phasing in period from 1 September 2021, the legacy SEN provision data items

and categories are to be removed this year. This takes effect from the 2025/26 academic year and first collected in the PLASC data collection to take place in January 2026.

From 1 September 2025 the terminology used within documentation and the software code, e.g., XML tags, will be converted from the legacy SEN terminology to the new ALN terminology.

This means that the PLASC data collection to take place in January 2026 will be the first to be impacted with the full removal of SEN legacy data and implementation of any new ALN data elements.

As a result of the SEN system coming to an end in Wales in August 2025, the data items related to SEN are to be removed from the PLASC collections for 2025/2026. These are changes that have been discussed at the Software Development Forum (SDF) since 2021, detailed in previous years' software specifications, and in more detailed discussions at the SDF ALN Sub Group since October 2024.

### **Additional learning needs data items introduced**

Following the end of the SEN system, and the removal of their related data items after August 2025, the new ALN system takes over and goes into its post-implementation phase from September 2025. As a result, the new ALN related data items are to be introduced. These changes, though technically new data items, are largely a terminology change from the previous SEN data items.

These items are highlighted within this document for ease of reference to suppliers.

## **2.5 Future changes**

### **School workforce related data elements**

As part of the workforce data elements being phased out of PLASC, it is intended to remove the remaining workforce data elements from a future PLASC collection. These include the teachers, teaching of Welsh and support staff data modules. This will be confirmed once the analysis of the data and implications of removing these data modules have been identified and reviewed.

### **Further language categorisation changes**

Following the introduction of the School Language Category data item for the 2024 data collection, there are ongoing considerations about the lower-level language-related data items, i.e., at class and individual level. However, at present, these are considerations for future data collections.

### **Further additional learning needs data item changes**

There will likely be further data items required, potentially from September 2026 onwards, to accommodate the data needs and requirements under the new ALN system. However, these will need to be subject to public consultation before being able to determine these and how they may be implemented. It is anticipated some changes may be required from September 2026 onwards.

## 2.6 Use of UPNs in reporting in MIS software

### Use of UPNs

When suppliers are designing reports for use by schools they should note that schools are advised that generally the Unique Pupil Number (UPN) should not appear in printed format. However, schools have had clear guidance that if this does happen, the printed document should be kept securely and shredded immediately to prevent inappropriate use or a breach of security. This advice is equally valid for MIS software used in local authorities and for reports produced by that software.

In addition to the above, any reports that appear in printed format should ensure that they comply with the [Data Protection Act \(DPA\) 2018](#).

### UPN generator

It is possible that there will be a number of pupils for whom a UPN has not been allocated e.g., a pupil who has never been registered at a maintained school. If no existing UPN can be found for a pupil, a new UPN must be allocated by the local authority using the UPN generator located on the Department for Education's (DfE) website at:

<https://www.gov.uk/government/publications/unique-pupil-numbers>.

The UPN generator is maintained by the DfE and a new generator is made available each academic year.

## 2.8 Use of ULNs in reporting in MIS software

The [Welsh Government](#) is facilitating the allocation of Unique Learner Numbers (ULNs) for pupils aged 14 and over in maintained secondary schools in Wales. ULNs have been collected through PLASC since January 2012 where appropriate. The ULN is an important administrative tool which will bring benefits for learning providers and learners.

## 2.9 Exclusions from PLASC

Exclusions data in PLASC is for any pupil who was excluded at any point during the previous academic year, which is any time from **1 September 2024** to **31 August 2025** regardless of their current provision. This should include any pupil

on roll in the previous academic regardless of whether they are still on roll at the school or not to provide a full picture of exclusions.

It is possible and acceptable for a pupil who has moved from EOTAS provision to school provision (and therefore be recorded in PLASC 2025) to have exclusions reported for them if they were excluded from a PRU during the last academic year.

Both fixed term and permanent exclusions must be reported.

The [Welsh Government](#) will perform comparisons of the data between PLASC and EOTAS and validation checks are in place to avoid duplications. Any duplications which are found will be investigated with the local authority as part of normal validation processes.

## 4. User requirements

Several default values are recommended, and auto and block fill requirements are requested to minimise bureaucratic and administrative burdens in the process of producing an accurate PLASC file.

### 4.1 Mandatory/optional items

Items marked as **M** (mandatory) in the XML example file are required data items. Schema checks will fail if these items are not present. Valid data is required for each mandatory field.

Items marked as **O** (optional) in the XML example file may be missing. If no data is present then the 'no data, no tag' rule applies.

### 4.2 Default values

Where the recommended default values are applied to items they should function as follows:

- `<Pupil><NAWPupilStatus><PartTime>` may be defaulted to **0** if `<DOB>` before **2020-09-01** (1 is now permissible, though queried, for all ages);
- `<Pupil><NAWPupilCharacteristics><EALAcquisition>` should be defaulted to **0**;
- `<Pupil><NAWALN><ALNSupportPlan>` should be defaulted to **N**;
- `<Pupil><NAWALN><ALNType>` should be defaulted to **DNA**;
- `<NAWClasses><Class><YearGroup>` and `<KeyStage>` may be derived where pupils' `<NCYearActual>` values indicate a single value, but no default should be applied otherwise. Both values refer to the curriculum or curricula actually followed by pupils in the class; and
- `<Pupil><NAWPupilStatus><EnrolStatus>` may be defaulted to **C** for all school types.

All data under the `<Exclusions>` node are mandatory in Wales. This differs from the position in England. `<Pupil><NAWExclusions><StartDate>` is mandatory for Wales. The `<Exclusions>` container should remain optional for schools where no exclusions have taken place, but it is mandatory for all exclusions to be reported in PLASC 2025, both fixed term and permanent.

No defaults other than those above should be applied.

### 4.3 Block entry

A block entry facility for fields could be used by schools at the beginning of the academic year to reduce burdens. This should allow schools to choose a selection of pupils (e.g., a year group, registration group or class) and specify a value to be applied to all. It should also allow data to be edited on an individual basis. The following fields may benefit from this facility:

#### 4.4 Autofill values

Fields which are dependent on the value of other fields should be autofilled when there is no doubt as to their value. These items are:

- <HomeWelsh> must be **2** if <SpeakWelsh> = **3** or **4**
- <ALNType> must be **DNA** if <ALNSupportPlan> = **N**

#### 4.5 Prompts

Suppliers may wish to consider whether a prompt, message or other enhancement may help to remind schools that the data items S1003<**FreeBreakfastsCensusWeek**> and S1004<**FSMpupilsFreeBreakfastsCensusWeek**> relate to the numbers of pupils rather than the numbers of free breakfasts. Please note that this data applies to the week before the week containing the census day.

#### 4.6 Miscellaneous

##### Special characters

The XML convention, which should be followed, is to use '&amp;' for '&' and '&gt;' for '>'.

The [Welsh Government](#) XSLT uses **UTF-8** encoding for special characters outside of the Latin character set. This is mainly for accurate Welsh translation of error messages and reports. The [Welsh Government](#) specifies **UTF-8** encoding to produce error and summary reports when using the [Welsh Government](#) produced XSLT files but does not require the encoding reference in the XML files produced by suppliers to be **UTF-8**.

## Boolean values

The set of allowed values is **1** (where true) and **0** (where false).

## XML tags

All modular **containers** have been named with the 'NAW...' prefix to ensure no confusion between modules agreed for use in England by the Department for Education (DfE).

## Maximum values

Some fields can have upper limits applied on an annual basis to reduce the probability of error in reporting a data item where a defined codeset is not available. For 2026 these are:

- **<FederatedGoverningBody>** maximum value of **F0200**.

## 5. File naming convention

### 5.1 XML data extraction

Long file names will be used.

The file extension will be XML.

The file name shall be constructed from the following components:

- (a) origin identifier (7 digits)<sup>1</sup>
- (b) survey/data extraction type (3 characters)<sup>2</sup>
- (c) destination identifier (7 characters)<sup>3</sup>
- (d) serial number (3 digits)<sup>4</sup>

The components should be separated by underscore characters (“\_”).

An example of a **Pupil Level Annual School Census (PLASC)** file from a school to a local authority would be:

**6602050\_ASC\_660XX26\_001.XML**

where **25** are the last two digits of the academic year, and therefore appropriate to the annual school census with a census date of **20 January 2026**.

The total file name length is 27 characters. For files not yet authorised by the school, the file extension should be changed from **XML** to **UNA**.

<sup>1</sup> For transfers from schools, the first 3 characters of the origin identifier will be the LEA number of the sending school and the final 4 characters will be the WG school number of the sending school. For transfers from LAs, the origin identifier will be the LEA number of the sending LA and the WG school number to identify the submission. For transfers from central organisations, the origin identifier will be the common abbreviation of the receiving organisation (e.g. NAW, Estyn) followed by “XXXX”.

<sup>2</sup> For PLASC data the survey type will be “ASC”.

<sup>3</sup> For transfers from schools to LAs, the destination identifier will be the LEA number of the receiving LA followed by “XX” and then “26” where “26” is the last two digits of the academic year. For transfers to central organisations, the destination identifier will be the common abbreviation of the receiving organisation (e.g. NAW, Estyn) followed by sufficient “X”s to complete seven characters.
